- (ii) if a "Black" Rainstorm Warning Signal is issued or "extreme conditions" is announced by the Government (via the Information Services Department) within two (2) hours before the tender closing time and/or remains in force beyond the tender closing time; or
- (iii) when the Director of Housing announces the closure of the Housing Authority Headquarters due to unforeseen circumstances occurring before and beyond the tender closing time; or
