 4. Only eligible contractors in the relevant List(s) / Group(s) above or qualified / shortlisted contractors of respective tenders will be considered for invitation to tender.
 5. For those contractors are interested in Open Tender or require further information in submitting an Open Tender, they are required to notify Principal Technical Officer (Building Services)/Technical Development 2 (PTO(BS)/TD2) of the Housing Department in writing in English or Chinese at the following address [within one week after Tender Notification].

6. Inclusion on the above List(s) in any particular Category or Group does not give contractors the right to tender for any Contract in that or any other Category or Group. The number of contractors invited to submit tenders for each individual Contract may be limited, with the list of contractors invited to tender on each occasion being at the sole discretion of HA. Selected contractors will then be formally invited separately to tender for each Contract.
7. Conditions of tenders and tender documents can be collected by selected contractors at the address as shown in the 'Letter of Invitation to Tender'.
8. The Contract(s) will be awarded by the Hong Kong Housing Authority.
9. Once contractors have notified HA of their intention to tender and have been invited, they are obliged to submit a tender in compliance with tender conditions and in accordance with the timeframe as described in the 'Letter of Invitation to Tender' which they will receive at a later stage. Failure to respond to the invitation, to collect the tender documents and / or to submit a tender in compliance with tender conditions will be considered as a tendering irregularity and the contractors concerned may be subject to appropriate regulatory actions.
10. For those who are not on the respective DEVB Lists but interested in undertaking HA Air-conditioning and Mechanical Ventilation Contract(s), they are required to apply to DEVB for consideration for admission on the DEVB List of Approved Suppliers of Materials and Specialist Contractors for Public Works - Category: Air-conditioning Installation before they can undergo the pre-qualification assessment by respective teams of the Housing Department.
