	1. Personal Particulars: Marital Status
	A married person, whose spouse's "One-way Permit" is not yet
	issued, declares to be "unmarried";
	A divorced person declares to be "unmarried"

	person, whose spouse's "One-way Permit" is not yet issued, declares
	to be unmarried; and a divorced person declares to be unmarried.

	Any person who knowingly makes any false declarations in respect of
	an application for PRH shall be guilty of an offence.

	The offender is liable to a maximum fine of HK\$50,000 and to
	imprisonment for six months. The PRH application will be cancelled.
