Express Flat Allocation Scheme (EFAS) Flat Selection Arrangements During Tropical Cyclones/Rainstorms/ "Extreme Conditions"

Generally, flat selection is conducted in the morning of the working days (Monday to Friday, excluding Public Holidays) only. Under this Scheme, flat selection has to be conducted according to the flat selection priority of each applicant. Attention is therefore drawn to the special arrangements stated below for situations where Tropical Cyclone Warning Signal No. 8 or higher is hoisted, a black rainstorm warning signal is issued or "Extreme Conditions" is announced on the flat selection day or where such signal/warning has been in force before or during the flat selection day, or two or more consecutive working days before the flat selection day:

(C) Signal/warning issued for three or more consecutive working days

If all or some of the flat selection sessions cannot be carried out as scheduled for three or more consecutive working days as a result of the issue of the signal/warning, Housing Department will speed up the flat selection procedures to clear the backlog of cases. As there is a large variety of combinations, the details given are not exhaustive. Applicants, however, can obtain information on the latest arrangements through the Housing Authority / Housing Department Website or Housing Authority Hotline on the working day following the cancellation of the signal/warning ^(Note 2).

- ^(Note 1) The whole flat selection process takes about one or two hours. For the safety of the applicants who have to travel to the flat selection venue or from the venue to home, we should ensure that they can return home as soon as possible after a pre-signal/warning announcement is issued two hours before the hoisting of Tropical Cyclone Warning Signal No. 8 or higher. Therefore, once a pre-signal/warning announcement is issued, only those flat selection sessions that have already commenced will continue, whereas all those that have not commenced yet will be cancelled. The Housing Department may also suspend the flat selection sessions that have started at any time having regard to the prevailing weather condition.
- (Note 2) As it takes time to re-arrange the flat selection sessions, the information may not be ready until a later time after the office has resumed operation.
- ^(Note 3) As there are bound to be a large number of people at the re-scheduled sessions, applicants are advised to follow the Revised Schedule as far as possible when they come for flat selection. Applicants who are not able to come in person may authorize their relatives/friends to select a flat on their behalf by completing the attached authorization letter or contact the Housing Department for special arrangements after the office has resumed operation.
