Note 1: The average monthly income base on the irregular income of the past 12 calendar months before the date of declaration can be adopted to calculate the average monthly salary of the applicant. For those who have been employed continuously for less than 12 calendar months before the date of declaration, the average monthly of the irregular income during the corresponding period of continuous employment before the date of declaration will be taken.

Note 2: The average monthly income should be calculated by adding up the income for the period of continuous employment in terms of months or days before the date of declaration and divided the total amount by the corresponding months or days of employment.
