**Points to Note on the
Application for Rescission**

If an applicant, for whatever reasons, opts to rescind the agreement to purchase a GSH flat before paying the balance of the purchase price, a sum equivalent to 5% of the purchase price will be retained from the deposit as consideration for the Hong Kong Housing Authority's agreeing to cancel the Agreement for Sale and Purchase and not as a penalty. The remaining amount, if any, will be returned without interest to the purchaser. The purchaser shall have no further right or claim thereof.

The applicant should first submit a written application to the Green Form Subsidised Home Ownership Scheme Sales Unit, which should include contact telephone number(s) and bear the signature(s) of the purchaser(s). Upon receipt of application, our staff will arrange an appointment to complete the formalities for the rescission. The applicant is required to return the Deposit Receipt (**HD 213B**) and the Agreement for Sale and Purchase in the appointment.
