I am happy to join the occasion and share the experience with our friends in the industry

in enhancing the safety on site and property management

The Housing Department (HD) is a very important working partner of the

Occupational Safety and Health Council (OSHC)

There are more than two million people living in public housing in Hong Kong

HD is not only responsible for the construction of new homes

It also bears the responsibility of the maintenance of its properties

It bears heavy responsibilities

How to effectively manage different sites

to ensure the safety of construction workers?

It is a great challenge

We are happy to see that

over the years HD has endeavoured to

introduce new safety management systems and technologies

and has been a pioneer of the industry in enhancing the safety on sites

Twenty years ago

HD and OSHC collaborated to

introduce an independent safety auditing system

to assess the occupational safety and health performance of HD's new works

Today, OSHC has taken a further step to carry out site safety audits

for HD's building maintenance and improvement works contracts

and surprise safety inspections on new works projects All these policies aim to enhancing the quality of safety management for the protection of the safety of construction workers During a recent visit to a HD site, my colleague heard a project safety officer saying to the workers that safety measures are not done for show but to protect our lives so that we can safely return home every day I believe by effort over the years the values of safety culture have been disseminated to our contractors and working partners Being our invaluable partner, HD has been encouraging its working partners to develop and promote new safety knowledge and technologies The Forum today is one of the good examples giving us an opportunity to explore together the safety of work at height Workers usually carry out their work at a height of two or three metres above the ground If safety precautions are inadequate it can lead to death in case of serious accidents So we should not underestimate the risks In addition, I would like to thank HD for its support to the "OSH Star Enterprise" Scheme by incorporating the employment of star enterprises in the specifications of its New Works contracts When contractors are engaged in scaffolding works they are required to employ star enterprises accredited by OSHC Employing star enterprises is a win-win situation The star enterprises adopt better safety management systems They have passed the safety audits It helps reduce the risk of accidents and ensure the progress of the project We are going to hold the Charter's Kick-off Ceremony next month I hope all my friends here will join us so that we can work together to enhance the safety standard in the industry Ensuring safety, in fact, is a shared responsibility Owners, contractors, subcontractors site safety officers, works supervisors or frontline workers all have a role to play By controlling risks at source

we can achieve the goal of "Safe Work and Zero Incident" so that every worker can go home happily every day and have dinner with their family
