With vaccum cleaner connected to the cutting machine, there is no dust on the site.

The LD standard is about the impact protection of the side.

When working, there are chances that the helmet will be hit from the side. In general the helmets protect the top of the head, but the side is not tested. I am not doubting their degree of protection, they just did not conduct related tests.

But our products are tested, and it is more protective.

We have other safety products, but today I mainly introduce the characteristics of this helmet. If you are interested in other products you can visit the exhibition booth Thank you.
