In recent years, there are many serious industrial accidents which involved the renovation and maintenance workers

falling from height leading to serious accidents.

What are the substantive measures of the Labour Department to help the industry to reduce these accidents?

The screen shows that Mr. Lee-Wai-cheong, Divisional Occupational Safety Officer is answering the question.

Regarding the accidents involving fall of person from height in renovation and maintenance works, the Labour Department has

the following measures: The first one is to strengthen the law enforcement and

urge the industry to pay attention to site supervision.

Besides, we also deal with systemic crisis.

In this regard, Labour Department has published occupational safety alerts for

dangerous incidents caused by work at height and high risk activities.

We systematically identify the causes of the accidents and incidents,

develop relevant measures to avoid the accidents, and

strengthen safety promotion.

Recently, we have strengthened the measures at the source

to improve the safety awareness of the stakeholders.

We have recommended to the upstream stakeholders, such as trade unions, associations of contractors, or Owners' Incorporations, owners or tenants,

for promoting and enhancing their safety awareness, thereby adding safety measures in their contracts.

This serves to enable different parties to comply with relevant safety legislation and improve work safety.

What kind of training courses and small and medium-sized enterprise subsidy scheme are provided by OSHC for helping the industry?

There are some short term courses for cleaning industry. The 3.5-hour training course for frontline workers is a worthy recommendation.
Regarding the SME subsidy scheme, you can read it during the breaks.
Recently there was a subsidy for purchasing safety helmets. Each successful SME application will get up to 80,000 dollars for purchasing 20 sets of safety helmets with chin straps. In addition, there is also a portable circuit breaker of which the retail price has dropped from 500 dollars to 350 dollars. The promotion plan played the role of a seed which is welcomed and supported by the industry for heading towards the goal of zero incident. Thank you.
