A while ago in Hong Kong

an elevating work platform used in street lamp installation collapsed

Its arm was extended excessively, lost balance and collapsed

If this elevating work platform is on a vehicle

there's a design framework with a limit switch

When the system detects any operation outside the safety range

operation will be stopped

If it does not stop, it must have been tampered with

If it does not stop, it must have been tampered with

Would Mr. Lau please take this question?

It was mentioned just now that main contractors are required to report accidents

If they don't report

how can Housing Authority find out?

If violation is detected, what are the consequences?

I mentioned briefly just now

Labour Department (LD) provides SIS

to our Safety and Health Unit (SHU)

for EMD maintenance and improvement works contracts

or new works contracts

We will be the first one to receive everything

Upon receiving them, we will check the records

If in our system, there's no record of an incident report

If in our system, there's no record of an incident report

we will follow up with the project team

A few cases are under investigation now

The project teams are working hard

to get details from the contractor

Why is there no report from the contractor

Most of the time, contractors claimed that

the worker is nowhere to be found

or the worker was late in reporting, or it's a suspicious case

We have seen many contractors

sending similar replies to the project teams

Upon receiving a reply, we will first seek to understand

before making a judgment

The Internet is very powerful

It's unlikely to evade Internet tracking

All eyes are watching, videos can be uploaded on the Internet

All eyes are watching, videos can be uploaded on the Internet

Then, someone might direct me to it

"Mr. Lau, do watch it! I have sent you a video"

After watching, my colleagues and I will follow up at once

Which site?

It is difficult to evade responsibility

Thus, the most important thing is to prevent accidents

Manage your own site carefully

It is impossible to escape all watchful eyes
